Topic: Anti-competitive IP transactions? The intersection of patent and competition law in Australia and overseas



One year on from the repeal of s51(3) of the Competition and Consumer Act, barristers Cynthia Cochrane and Catherine Bembrick will explore the intersection between patent law and competition law in Australia and overseas, including:

- the application of the Competition and Consumer Act to agreements involving patent rights;
- ACCC guidance on how to approach such agreements;
- recent UK/EU authorities addressing contravention of competition laws in patent settlement agreements; and
- an exploration of related issues in the Calidad v Seiko Epson appeal to the High Court.

Speakers: Cynthia Cochrane, Barrister, 5 Wentworth Chambers

Ms Cochrane specialises in high-profile patent cases and commercial cases, including competition law. She has expertise in biological medicines. She appears regularly in the Federal Court and NSW Supreme Court. She also appears in the Patent Office and conducts ACCC examinations. She appears unled and against Senior Counsel in trials, appeals and interlocutory disputes, and cross-examines on credit and scientific matters.
