Applications by Telstra and TPG (ACT 1 of 2022)
Australian Competition Tribunal proceedings brought by Telstra and TPG for merger authorisation of a mobile infrastructure and spectrum sharing arrangement in regional Australia

O'Higgins FX Class Representative Ltd v Barclays Bank plc and Others; Evans v Barclays Bank plc and Others (Cases 1329 and 1336 of 2019)

UK Competition Appeal Tribunal class action proceedings, with subsequent appeal to English Court of Appeal, brought by two representative applicants against banking groups alleging damages up to or exceeding £2 billion due to anti-competitive conduct involving FX trading found in two European Commission infringement decisions

Allianz Global Investors and Others v Barclays Bank plc and Others (CL-2018-000840)

English High Court proceedings, with subsequent appeal to English Court of Appeal, brought by investment, pension and other funds seeking multi-billion pound damages from banking groups for alleged FX cartel conduct alongside parallel proceedings in the US District Court (SDNY)

ACCC v Ramsay Health Care (NSD 628 of 2017)

Federal Court proceedings alleging misuse of market power and exclusive dealing with respect to the supply of private hospital and day surgery services

ACCC v Cascade Coal (NSD 584 of 2015)

Federal Court proceedings involving alleged cartel conduct including bid-rigging in connection with the NSW government tender process for certain coal exploration licences

Application by AGL (ACT 1 of 2014)

Australian Competition Tribunal proceedings brought by AGL for merger authorisation for its \$1.5 billion acquisition of certain Macquarie Generation electricity assets

ACCC v AGL South Australia (SAD 355 of 2013)

Federal Court proceedings involving alleged false or misleading representations with respect to discounts for electricity supply to residential customers
